- By choosing to be served on this rate, I thereby waive all rights to any billing adjustment arising from any claim that the bill for services would be cheaper on any alternative rate schedule for any period of time.
- I may opt out of this rate at any time to be billed on the Residential Service flat rate under Service Schedule 20 or 22, but cannot change rates more frequently than every twelve months.

- This rate requires hourly data and my meter may need to be upgraded by Minnesota Power (at no extra cost to me).
- This rate is based on when I use energy and if I am not able to shift my energy use, I could pay more than I pay with my current rate.
- I will periodically be asked to provide feedback via online surveys.
